

# Immunization Requirements for the 2012 - 2013 School Year

K.A.R. 28-1-20 defines immunizations required for any individual who attends school or a childcare program operated by a school. There are changes in requirements for immunizations for the upcoming school year. Please carefully review the requirements below. The usual number of doses required are listed; however there are exceptional circumstances that could alter the number of doses a child needs. If you have questions about your child's immunization status, contact your child's primary care provider or local health department. Proof of receiving the immunizations must be provided to the school prior to attending the first day of school.

- Varicella (chickenpox) vaccine is not required if child has had chickenpox disease <u>and</u> disease is documented by a physician signature.
  - Without a physician signature, vaccine is required even if you believe your child has had chickenpox disease.
- \*\* Although 1 dose of varicella is required for school attendance, 2 doses are recommended by the ACIP (Advisory Committee on Immunization Practices).
- \*\*\* All 7th 10th graders are required to have one dose of Tdap regardless of the interval since the last dose of Td (tetanus/diphtheria). This is to improve pertussis (whooping cough) immunity due to increasing outbreaks.
- \*\*\*\* All 11th 12th graders are required to have 1 dose of Tdap if there has been more than 10 years from the previous DTaP (pertussis containing vaccine). This is to improve pertussis (whooping cough) immunity due to increasing outbreaks.

#### Additional ACIP Recommended Vaccines, NOT REQUIRED for School Entry

- Influenza (flu) vaccine yearly for everyone 6 months and older
- Meningitis vaccine at age 11 years and a booster at age 16 years
- HPV vaccine (a three dose series) at age 11-12 years

#### School Entry Physicals

Any new early childhood program or kindergarten student will need a school entry physical completed within 12 months prior to the first day of school.

New students under the age of 9 years who are attending a Kansas school for the first time, also require a physical as described above.

Documentation of the physical must be provided to the school prior to attending.

Please Note:
If your child is not in compliance with required immunization by November 8, 2012 he/she will be excluded from school.

# **Mulvane Students to Participate in Body Venture**

An innovative new way to learn about the importance of good nutrition and physical fitness is coming to students at Munson Primary and Mulvane Grade School. On November 7 & 8, the Body Venture exhibit will visit MPS. Students will have the opportunity to explore the human body with Power Panther, the USDA Food and Nutrition Service mascot as their guide.

The tour begins when students, in groups of eight to ten, enter the school lunchroom and become a food such as a carrot, low-fat milk or a piece of chicken. In the second station, they walk through a giant ear into the brain. Inside the huge brain dome, students experience "brain waves" and learn about brain function. The "foods" step into the exhibit's larger-thanlife mouth, are "swallowed" through the esophagus tunnel and move into the stomach dome. From the stomach, the students travel through the small intestine where they are "absorbed" into the blood. Then they follow the path of the nutrients to the heart, lungs, bones, muscles and skin stations.

Students leave the body through a cut in the skin and proceed through Power Panther's Pathway to Life. This final station recaps key health concepts from each of the ten previous stations. Throughout the exhibit, students will learn how to apply Power Panther's slogan, EAT SMART, PLAY HARD. At each of Body Venture's eleven stations, a volunteer presenter engages the students in a five-minute activity focused on healthy choices.

The traveling Body Venture exhibit was developed and is operated by Child Nutrition & Wellness, Kansas State Department of Education. Cheryl Johnson, Director of Child Nutrition & Wellness said, "Body Venture provides a unique and exciting opportunity for Kansas elementary students to learn about their bodies and the importance of making healthy choices." According to Kathy Thompson, Body Venture Coordinator, the exhibit was developed to address increasing national concerns about the lack of physical activity and the declining nutritional status of young children.

# **Memorial Remembering Steven Dody**

Recently the flagpoles and memorial plaque honoring Steven Dody were relocated near the main entrance at Lyle Couch Stadium. The relocation of the memorial sparked the question - Who was Steven Dody?

According to Jeri Myers, 1966 MHS Graduate, Steven Dody grew up in Mulvane and graduated from Mulvane High School in 1996. Jeri remembers Steven as a star punter and wide-receiver on the Mulvane Football teams that never lost a game during his four-year high school career. Steven was a hard worker who worked part-time as an evening custodian for the school district.

Steven Dody passed away on October 16, 1991, when he and 22 other people were shot to death at Luby's Cafeteria in Killeen, Texas.

Jeri and MHS classmates of 1966 knew they wanted to honor their friend, his time in Mulvane and his career serving as an Army lieutenant colonel who was just two weeks from retirement. So it began, the class of 1966 raised enough funds to purchase and construct the original flagpoles and monument in memory of Steven Dody. The impressive memorial plaque at the newly constructed flagpoles reads:

Dedicated to the Memory of Steve Dody By His Friends and Classmates of 1966 July 9, 1948 - October 16, 1991





### **Inclement Weather**

The winter season is upon us, and with it comes the possibility of inclement weather affecting school opening. We understand that our decision to open or close schools in bad weather has a big impact on families. The safety and security of our students and staff is our highest priority.

The decision to close schools is based on the best information available at the time the decision is made. Although the staff and superintendent do their best in this process, we know that often no perfect decision exists. IF WE ARE OPEN AND YOU DO NOT FEEL THAT IT IS SAFE FOR YOUR CHILD TO ATTEND SCHOOL, THEN PLEASE DO NOT SEND YOUR CHILD. Please note the reason for absence is the inclement weather. You can always wait until the bad weather passes and then bring your child to school for the remainder of the day.

# How do we make school closing decisions?

The decision to open or close the schools in bad weather is based on a careful analysis of all the relevant factors, including:

- · Road conditions throughout the school district
- · Amount of snow and ice
- · Whether precipitation is expected to continue
- · Building conditions
- · Parking lot and sidewalk conditions at the schools
- · Temperatures and wind chill factors
- · Collaboration with surrounding school Superintendents

### Who makes the decisions?

 The Superintendent of Schools is responsible for the final decision, based on the above factors and input from the transportation and facilities departments, and collaboration with surrounding school Superintendents.

#### When is the decision made?

• The decision is typically made between 5:00 - 5:30 AM

### How is the public notified?

- You will be notified by a direct phone call from USD 263, using the *School Messenger* calling system.
- The notice is also posted on the local TV stations (Ch. 3, 10, 12) along with local radio stations-KFDI, KICT, KYQQ, KKRD, KRBB, KEYN, KFBZ, KFH

### What Can You Do?

Be prepared! When weather is threatening the night before, please have plans for the possibility that school may be closed.



# Family Educational Rights and Privacy Act (FERPA) Notice for Directory Information

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Mulvane School District, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Mulvane School District may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Mulvane School District to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the *Elementary and Secondary Education Act of 1965* (ESEA) to provide military recruiters, upon request, with the following information - names addresses and telephone listings - unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Mulvane School District to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing by the first day of school. Mulvane School District has designated the following information as directory information:

- -Student's name
- -Address
- -Telephone listing
- -Electronic mail address
- -Photograph
- -Date and place of birth
- -Major field of study
- -Dates of attendance
- -Grade level

- -Participation in officially recognized activities and sports
- -Weight and height of members of athletic teams
- -Degrees, honors, and awards received
- -The most recent educational agency or institution attended
- -Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be sued to access education records without a PIN, password, etc. (A student's SSN, in whole or in part, cannot be used for this purpose.)

These laws are: Section 9528 of the Elementary and Secondary Education Act (20 U.S.C. 7908) and 10 U.S.C 503(c).



# Notification of Rights Under the Protection of Pupil Rights Amendment (PPRA)

PPRA affords parents certain rights regarding our conduct of surveys, collection and use of information for marketing purposes, and certain physical exams. These include the right to:

- •Consent before students are required to submit to a survey that concerns one or more of the following protected areas ("protected information survey") if the survey is funded in whole or in part by a program of the U.S. Department of Education (ED) -
  - 1. Political affiliations or beliefs of the student or student's parent;
  - 2. Mental or psychological problems of the student or student's family;
  - 3. Sex behavior or attitudes;
  - 4. Illegal, anti-social, self-incriminating, or demeaning behavior;
  - 5. Critical appraisals of others with whom respondents have close family relationships;
  - 6. Legally recognized privileged relationships, such as with lawyers, doctors, or ministers;
  - 7. Religious practices, affiliations, or beliefs of the student or parents; or
  - 8. Income, other than as required by law to determine program eligibility.
- •Receive notice and an opportunity to opt a student out of -
  - 1. Any other protected information survey, regardless of funding;
  - 2. Any non-emergency, invasive physical exam or screening required as a condition of attendance, administered by the school or its agent, and not necessary to protect the immediate health and safety of a student, except for hearing, vision, or scoliosis screenings, or any physical exam or screening permitted or required under State law; and
  - 3. Activities involving collection, disclosure, or use of personal information obtained from students for marketing or to sell or otherwise distribute the information to others.
- •Inspect, upon request and before administration or use -
  - 1. Protected information surveys of students;
  - 2. Instruments used to collect personal information from students for any of the above marketing, sales, or other distribution purposes; and
  - 3. Instructional material used as part of the educational curriculum.

These rights transfer from the parents to a student who is 18 years old or an emancipated minor under State law.

Mulvane School District has developed and adopted policies, in consultation with parents, regarding these rights, as well as arrangements to protect student privacy in the administration of protected information surveys and the collection, disclosure, or use of personal information for marketing, sales, or other distribution purposes. Mulvane School District will directly notify parents of these policies at least annually at the start of each school year and after any substantive changes. Mulvane School District will also directly notify, such as through U.S. mail or email, parents of students who are scheduled to participate in the specific activities or surveys noted below and will provide an opportunity for the parent to opt his or her child out of participation of the specific activity or survey. Mulvane School District will make this notification to parents at the beginning of the school year if the District has identified the specific or approximate dates of the activities or surveys at that time. For surveys and activities scheduled after the school year starts, parents will be provided reasonable notification of the planned activities and surveys listed below and be provided an opportunity to review any pertinent surveys. Following is a list of the specific activities and surveys covered under this requirement:

- •Collection, disclosure, or use of personal information for marketing, sales, or other distribution.
- •Administration of any protected information survey not funded in whole or in part by ED.
- •Any non-emergency, invasive physical examination or screening as described above.

# Notification of Rights under FERPA For Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. These rights are:

(1) The right to inspect and review the student's education records within 45 days of the day the School receives a request for access.

Parents or eligible students should submit to the School principals (or appropriate school official) a written request that identifies the record (s) they wish to inspect. The School official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

(2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

Parents or eligible students who wish to ask the School to amend a record should write the School principal (or appropriate school official), clearly identify the part of the record they want changed, and specify why it should be changed. If the School decides not to amend the record as requested by the parent or eligible student, the School will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

(3) The right to privacy of personally identifiable information in the student's education records, except to the extent that FERPA authorizes disclosure without consent.

One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official is a person employed by the School as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the School Board; a person or company with whom the School has outsourced services or functions it would otherwise use its own employees to perform (such as an attorney, auditor, medical consultant, or therapist); a parent or student serving on an official committee, such as disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks.

A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the School discloses education records without consent to officials of another school district in which a student seeks or intends to enroll, or is already enrolled if the disclosure is for purposes of the student's enrollment or transfer. (NOTE: FERPA requires a school district to make a reasonable attempt to notify the parent or student of the records request unless it states in its annual notification that it intends to forward records on request.)

(4) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the School to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:
