6.0 DISCUSSION/ACTION ITEMS

6.1 Vaccination Exclusion Extension

Dr. Ensley shared information from our nurses regarding requirements for student vaccinations. The district allows a 90-day grace period. (Dec. 11 for the current school year) We have many students that have not met the vaccination requirement this year possibly due to restrictions/COVID. Our nurses have made multiple contacts with parents regarding this requirement. The Board discussed allowing a short extension to the grace period.

Motion made by Chris Heersche to allow a vaccination exclusion extension past Dec. 11 to December 31, 2020, with nurses communicating this update to parents. If the vaccination record isn't in compliance by then, remote only will be the learning option for the student. Second by David Sanders. Motion carried 5-0.

6.2 Emergency Authority to Change Learning Mode (if needed)

Dr. Ensley reviewed Sedgwick County, KDHE, and local numbers. He noted that there might be a need to change the learning mode temporarily if there were a State/County mandate or an inability to operate due to staffing shortages. These possibilities would require rapid action and would be temporary until the Board could meet.

Consensus of the Board was to allow the Superintendent to make the decision to temporarily change the learning mode if there was an emergency.
