## 6.3 MGS Roofing Bids

Mr. Brad Canfield shared bid information from the four contractors that responded to our RFP with a request for the main bid and an alternate at MGS. The low bid was from Buckley. Dr. Ensley noted this would be taken from Capital Outlay.
