All bids must be submitted in a sealed envelope marked "USD 263 Carpet Bid 2020". Contractor to enclose with bid proposal a copy of current liability insurance. Contractor will be required to sign a waiver of lien and verification that' sub-contractors and suppliers have been paid.

The scope of work is as follows:

- 1. Removal and disposal of existing carpet or tile and vinyl base trim.
- 2. Floor Prep for new installation.
- 3. Installation of new carpet and 4-inch vinyl base trim.
- 4. USD 263 will have all furnishings removed from each location for carpet installation unless noted.

Additional Information

- Floor Preparation: All floors shall be scrapped to bare concrete using a scrape away disc on a rotary floor machine to remove all old adhesives and assure proper adhesion of new materials. Floors will be patched as needed after scraping, including filling and patching cracks, holes and uneven areas. The floor must be level prior to any new flooring being laid.
- Waste Disposal: Bid will include removal and disposal of all existing flooring; removal and disposal of debris generated during the installation of new materials. USD 263 Dumpsters may not be used for project disposal. Job site will be left free of all scraps or trash generated during the process of installation.

- 3. **Square Footage:** The vendor assumes responsibility for accurate square footage of all areas listed in within this bid package. It is suggested that all vendors conduct site visits and take accurate measurements.
- 4. **Site Visit Information**: Interested contractors are encouraged to visit and inspect the school site prior to submitting a proposal in order to familiarize themselves with the work requirements.
